Narrative

A male white caucasian in appearance caused damage to the garbage can in the parking lot in St. Vital Park when he hit it with his personal hands and fist.

We are talking about the parking lot adjacent to the cemetery dirt road walkway and across from the children's play structure soccer field. The perpetrator male was about 35 years old with a large nose very agitated and aggressive like vibrating shaking as he approached me on foot while i was seated sitting in my own truck KMD 384 as the authorized agent of KFB Holdings Ltd. (paperwork registration available).

After he damaged the garbage can, he approached my vehicle there was a woman with him and the male assailant stood next to the outside of my driver's side door not touching it but so I could barely open it and then he backed up. He yelled to me through the window making a comment about "AIDS" and he said he wanted to talk to me. I said back through the closed door window that I didn't want to talk to him. He said again he wanted to talk to me so I opened my drivers side door 4" open and the characteristic smell of HIV virus and feces was foul and emanated from this male perpetrator. He slurred his words and said something like "chasing the..." and i replied "you're wrong" and i closed my door and left St. Vital park [St. Vital Road].

Incident Description

For the address I listed it above there is an ongoing dispute to be settled by way of hearing with the residential tenancy branch pending resolution re: bed bugs and electrical safety concern and the building owner landlord scheduled for bankrupty court in July 2024.

brown hair on head
some facial hair like 5 o'clock shadow
